#### Call to Order

The meeting was called to order by K. Morrison.

#### **Introductions and Welcome**

K. Morrison welcomed everyone.

#### Approval of the Board Agenda

It was moved and seconded,

That the Board agenda be approved as amended.

Carried.

#### **Declarations of Conflict of Interest**

There were no declarations of conflict.

#### Minutes of July 5, 2022 Board Meeting

It was moved and seconded,

That the minutes of July 5, 2022 be approved.

Carried.

#### **CPFF Financials**

V. Pringle reviewed the financials reports. She mentioned that:

- S. Lee has surpassed the revenue targets of \$475,000, as \$882,000 were raised during the recently ended fiscal year.
- Donations are well over budget.
- Expenses are currently under budget, but some outstanding July expenses are expected related to September awareness and ongoing projects.
- CPFF is currently sitting on a surplus, but a considerable portion of it will be deferred to the new fiscal year in order to be allocated to unfinished projects.

#### **Executive Director Report**

#### Pharma - BI & Roche

S. Lee mentioned that:

- She is still pursuing Roche for a grant in the \$40,000-45,000 range to help fund CPFF programs during FY22-23, which would come in addition to the \$90,000 already received in June for the FY22-23 Fellowship.
- \$205,000 will be received from BI. This includes \$140,000 from their marketing budget, \$60,000 for a collaboration project with McMaster University for a Patient Guidebook (which CPFF does not have the capacity to undertake) and \$5,000 to fund a support group in Windsor.
- She will be traveling to Prague to give a presentation about patient advocacy program and diversity, as well as to meet with Bl's global senior management to make the \$3,000,000 ask.
- She has asked BI Canada to move CPFF to the Medical department for funding requests rather than from Marketing, as their pool of available funds is much larger.
- An extension for \$150,000 for the Harmonize O<sup>2</sup> project is needed to avoid having to give it back from the original \$250,000 grant.

#### 2022 Hope Breathes Here

S. Lee mentioned that:

- Several speakers have been lined up so far for a total of 9 confirmed presentations (see line up below).
- R. Zapata has prepared a social media calendar which will help promote the speakers, as well as everything related to the Hope Breathes Here event.
- A discussion with support group leaders is needed before having them meet, as previously proposed.

#### Webinar line up:

- Nutritionist Tracey Reed will present on Anti-inflammatory Diet for PF
- Dr. Richard Allen will present on The Genetics of PF
- Audrey Bond, CEO, will present her app Vaultt, designated for patients and caregivers
- Dr. Marcelo Cypel will present on Creating Universal Blood-Type Organs for Transplant
- Karine Diedrich form CHPCA will present on Advance Care Planning
- Dr. Amanda Grant-Orser and Dr. Kelly Johannson will provide a research update
- T. Georgieff will present on Clinical Trials
- Dr. Elisabeth Saxton will present on Mental Health
- Colin Edwards will present on Novel AI diagnostics and technology in PF

#### **Governance & Finance Report**

#### **Board Applicants**

R. Protti mentioned that the Governance & Finance committee unanimously recommend 4 individuals as Directors, and 1 as a volunteer.

It was moved and seconded,

That Nicole Hilliard, Peter Kleinstiver, Derek Mastin and Winston Fiander be appointed as CPFF Directors, and Murray Walz be appointed as a patient-advocate volunteer on the MAB committee.

#### Carried.

M. Martin mentioned that this would be a good opportunity to introduce the orientation program, during which they will start by receiving a welcome letter and they would then be paired up with a director that can mentor them for at least 1 year. She asked whether anyone in the Board would be interested in taking up that role.

The newly appointed Directors will be asked how they would like to be introduced, so the community can be informed that CPFF has new people on the Board.

- R. Protti will let all of them know that the Board has approved their appointment and they should expect a letter, and S. Lee ought to be CC'd in all relevant communications.
- K. Morrison will also update a welcome letter from the previous year and share it with R. Protti.

It was mentioned that besides the MAB volunteer position, a volunteer position within the Advocacy & Support committee can also be offered.

It was also mentioned that the new Directors have not expressed which committees they would like to join.

#### J. Dinner

M. Martin asked S. Lee to pay J. Dinner the remaining of the \$15,000 owed to him.

The latest round of reviewed policies will be discussed and reviewed during the next Governance & Finance committee meeting, so they be approved at the next Board meeting.

It was mentioned that those that are unable to participate in person may do so virtually. S. Lee will look into optimizing the virtual experience.

#### **December Virtual Open House**

The event will feature the same format as last year. The Board agrees with the proposal of inviting pharma and sponsors to a luncheon before the event in order to honour Heather Davidson's contribution to CPFF.

A Director was concerned about the accessibility of the event and proposed running the meeting outside of work hours. It was countered that the 4-hour time difference between the Canadian time zones on both extremes of the country exacerbate the accessibility problem and makes it difficult to fully address.

#### **Advocacy & Support Report**

#### **Advocacy Campaign**

M. Ashcroft mentioned that the OFEV advocacy is complete. Nunavut is the only territory to not have come on board, but most people in the territory are covered by the NIHB.

He added that the Advocacy & Support committee is presently looking at oxygen advocacy opportunities.

He also added that the eventual meeting between support group leaders needs to be carefully monitored, as there's a lot of strong opinions among support group leaders and the fact that

some leaders are remunerated by other organizations may create some tension with the leaders that are volunteers.

#### Puneet Luthra Services – PSL Government Relations

S. Lee provided some background on P. Luthra.

It was moved and seconded,

That the services of Puneet Luthra Consulting Inc. (at \$125 per hour + HST) be retained for Government Relations for up to 10 hours per month.

#### Carried.

#### **Winnipeg Support Group**

M. Ashcroft mentioned that the Winnipeg support group is hosting a conference on September 13<sup>th</sup>, and that they are asking if CPFF can contribute some money and swag.

The Board had a lengthy discussion about the implications and ultimately it was agreed that M. Ashcroft should ask the support group what is the monetary contribution they would need. Additionally, it was proposed that the Advocacy & Support committee discuss what would be an acceptable stipend to provide all support groups annually.

Due to the time sensitivity of the subject, M. Ashcroft with follow up with Debbie Homik, Winnipeg's support group leader, through email and follow up with the Board prior to the next Board meeting for a decision.

It was also proposed that the Advocacy & Support committee discuss what kind and quantity of swag could be provided to support groups across the country.

#### **Communications & Fundraising Report**

#### **Patient & Caregiver Survey Results**

T. Georgieff provided a summary of the Patient & Caregiver survey results, which was analyzed by Etal Marketing and Pearl.

Among other things, the survey results uncovered:

- Good data concerning oxygen
- That caregivers need more support
- An under-representation from Quebec
- An over-representation from the West

One piece of feedback from the survey was that it has gotten quite long.

The Communications & Fundraising committee asked Etal and Pearl to provide a one-page infographic for September. An updated report will also be provided in time to be presented during the October Board meeting.

#### **Hope Breathes Here Campaign**

#### **CPFF Board Minutes of August 5, 2022**

R. Zapata will create a cheat sheet for the app and will make it clear that CPFF is the organization and that Hope Breathes Here is the September project.

#### **New CPFF Website**

T. Georgieff mentioned that there have been some delays in the launch of the website, and that it should go live no later than August 22<sup>nd</sup>.

#### MAB Report

C. Fell mentioned that she's trying to line up speakers for September.

She also mentioned that G. Vidyasankar is still working on the Harmonize O<sub>2</sub> paper.

To address a director's concern on whether the Patient & Caregiver survey results have been useful, C. Fell mentioned that she used the publicly available data for grant applications and presentations. She cannot, however, speak on behalf of the usage level of the publicly available data by her colleagues.

S. Lee mentioned that P. Luthra stated that he could use publicly available data to apply for provincial funds.

The meeting was adjourned at 4:58 pm EST.

I am happy that the Board is willing to discuss MAGIC GIFTS children's storybook at their next meeting in September 2022.

#### INSPIRATION:

I was inspired to write MAGIC GIFTS ,as I have a dear friend, John Robinson who is seriously ill with pulmonary fibrosis. He is on oxygen twenty four hours per day. He invited me to be the Ride Coordinator and Communications Officer for John Dennis. I did not know much about the disease, but as the weeks went by, I learned much about pulmonary fibrosis and organ donation.

John Dennis also inspired me with his ongoing advocacy for pulmonary fibrosis patients, and the desire to establish a CPFF research fund. John is also very ill now, and goes to the hospital frequently.

I have dedicated MAGIC GIFTS to John Robinson and John Dennis. I feel there is an urgency to have MAGIC GIFTS printed as soon as possible, with the present circumstances.

#### FIRST REQUEST:

Requesting CPFF endorse MAGIC GIFTS. The CPFF logo would be on the front cover of MAGIC GIFTS with the sponsors. Also requesting a written endorsement from the CPFF Executive Director or other official. This is usually just a paragraph or two. The endorsement would detail the reason CPFF is interested in MAGIC GIFTS. It would also outline the educational value of MAGIC GIFTS for grades 4, 5 and 6 students. The endorsement would be included on the Acknowledgement Page with the sponsors.

#### RATIONALE FOR CPFF ENDORSEMENT:

The I RIDE FOR YOU AND ME - JOHN DENNIS fundraiser would be one reason that you might be interested. This fundraiser was the official kick-off for the HOPE BREATHES HERE national campaign.

MAGIC GIFTS talks about OFEV, oxygen concentrator and portable oxygen concentrator. It also talks about the use of a three wheel trike for mobility.

John Robinson successfully lobbied the Premier of P.E.I. and his officials to fund OFEV for ALL pulmonary fibrosis patients.

John Dennis also lobbied the Premier of P.E.I. and Hon. Ernie Hudson for OFEV and organ donation legislation. We believe new donor legislation will be implemented this fall.

I have personally spent countless hours working on the I RIDE FOR YOU AND ME - JOHN DENNIS fundraiser. I sent many, many press releases to the various forms of the media including radio, television and newspaper.

I mention the Canadian Pulmonary Fibrosis Foundation HOPE BREATHES HERE campaign in MAGIC GIFTS.

I am very pleased that Premier Dennis King, Hon. Ernie Hudson and Mayor Philip Brown acknowledged MAGIC GIFTS by lending their names, as they were mentioned in the storybook.

#### **MAGIC GIFTS**

Two of the most beautiful "magic gifts" that we could ever receive are - family and friends. They help us travel along both smooth or bumpy roads! But, when a family member or friend takes you by the hand and says, "How are you today?" or "What can I do to help you?" These words are from their heart. They are magic gifts to you.

Let me tell you about two men, who became new acquaintances. Guess what? Both of their names are John; one is John D. and the other is John R. They did not know each other when they were young boys. But, they do have lots of things in common today.

These gentlemen worked very hard, in their younger years. They were very successful in business ventures. John D. first worked in a bank, and later, he was a Manager of shopping centers, in many different cities. However, John R. stayed in Prince Edward Island, where he and his family had a large farm and grew potatoes, soybeans and barley.

Both men married; then, they had children and grandchildren. Each man is very kind, considerate and thoughtful. They both have tried to help as many people as they can, in different ways, throughout their lives. They are the picture of "magic gifts" to many that know them.

One of the fun things that they remember about growing up is their first bicycles. John D. recalls riding a one-speed bike, and John R. has fond memories of pedalling a very old tricycle around the barnyard, at home on the farm. Then, his father gave him a new, shiny red, CCM bicycle to pedal the two miles to school, as there were no buses in those days!

But, guess what else was the same? The two men have recounted identical stories, that neither of them had ever ridden a bicycle again after they grew up, for at least forty years! Little did they know that bicycles would be very important to them when they got much older! For you see, magic gifts would come to them for a purpose they never imagined. But, you will have to wait a bit for that exciting part of their stories!

We know that gifts come in all shapes and sizes - small, medium and large. Most of the time, they are in a box, wrapped in pretty paper, and often, have a neatly-tied matching bow, on the top. The magic part is trying to guess what is inside! Gifts are given on many different occasions, like birthdays, Christmas, graduation or just because we are thinking of someone in a special way. Magic gifts come when we least expect them and are certainly very much appreciated. That is what happened to both John D. and John R.

First, let me tell you about John D. A few years ago, John developed what we call Type 2 Diabetes. This is when there is too much sugar circulating in your bloodstream. This sugar is also called glucose. Healthy eating and exercise can certainly help with this problem, but often medication, or insulin therapy, is needed to control this condition.

Then, quite a while later, John D. noticed that he was very tired all the time, and having trouble breathing when he walked. He decided to visit his Doctor, who sent John to the hospital for x-rays, and other tests. The Doctor told him he had *Idiopathic Pulmonary Fibrosis*. This disease is called "IPF", for a shortened name. It is caused when the lungs are not functioning properly, and scarred tissue replaces healthy lungs. John knew a lot about this disease already, as other family members had suffered from this before he did. There is no known cause, or cure, for IPF.

The word, pulmonary, relates to the lungs. Lungs are very important organs in our bodies. I am sure you know that your lungs help you blow up balloons. Or, a bagpiper blows air from the lungs, to inflate the bag part of the bagpipe, so he or she can make music with this instrument. Your lungs are two balloon-like organs, used for breathing.

Breathing is a process that moves air in, and out, of the lungs. Oxygen is breathed in, and carbon dioxide is breathed out. We all need this gift of oxygen to live. The lungs are located on either side of the heart. The oxygen that they provide then goes to every cell of the body, through our bloodstream, so we will remain healthy. They are certainly a complex, but magical gift, in our bodies.

Well, John D. continued to struggle for his breath, and became very ill. Some of his closest family and friends became very worried. It is okay to have these feelings when we do not understand what is happening to one that we really love or care about!

Those very close to John D. knew he had already received some wonderful magic gifts while he was feeling ill. But now, the time had come when he required an extra gift. Children began to imagine that it was in a small blue box, with a fancy navy bow on top. Really though, inside was a gift called OFEV. This medication helped to slow down John D's illness. Esbriet is another medication also used for IPF patients. Some people, with this disease, find Esbriet very helpful for their lungs to work better and longer.

However, John's health continued to get worse. The Doctor once again decided that John should be given another magical gift. The children's vivid imaginations pictured a medium sized, red box, with a fancy gold bow on top. Inside was a Portable Oxygen Concentrator. This is a piece of equipment that goes over the face, with tubing attached. It helped John breathe much better. This gift was magic, as John was getting way more oxygen into his lungs, and also, it was portable, so John could even go outside.

But, as time went on, John D. now needed even more oxygen. Again, boys and girls could picture a large, purple box with a pretty silver bow. Tucked inside was a much bigger Oxygen Concentrator than John had ever had before. It supplied him with oxygen, twenty-four hours a day, seven days a week.

After four more years, John knew he was not getting any better and he would need a very special magic gift. He wished for this gift often. Yet, he had to wait for a very special, generous person to make it happen. Are you imagining what this gift could be? Here is a clue. You can not buy this magic gift. It does not come in a box - no colourful wrapping or pretty bow, but it would come in a special "cooler"!

You see, John wished for a lung transplant. This would certainly be a "Gift of Life." The donor, who would donate his/her lungs, may have died from an illness or had been in an accident. However, there are "living donors" who can help their family, a friend or a complete stranger. Doctors do a lot of testing with the living donor, and also with the person who needs a new organ. That person is called the recipient. Often it is a family member who is found to be the best match.

Many different organs can be donated and they help save thousands of lives every year. There is a long wait list for someone to receive a transplant. John D. finally got a call, and soon had his surgery.

After nearly two weeks in the hospital, John recovered from the transplant, able to walk long distances, and even up and down steep hills! Everyone was thrilled that John D. was feeling so much better. He was so thankful for the magic gift of a transplant that saved his life.

John R. has a very similar story that he tells. He had the same symptoms that John D. had - tired and out of breath. Now John R. knew he was not a doctor, but he thought maybe he had pulmonary fibrosis, as his father and uncle had this disease years before him.

When tests, and the Doctor, confirmed it was IPF, John R. and his family were very sad, just like John D.'s family had been. John R. started daily OFEV medication immediately. He began using the Oxygen Concentrator, as a great tool, to provide him with more oxygen in his lungs. He had been using this machine, at home, for three years, and realized that he could not leave home without oxygen. However, John's problem was magically solved when a wonderful gift arrived. A very close friend gave him a battery- assisted Pulmonary Oxygen Concentrator! Now, with the two sizes of the concentrators, John can carry the smaller one around on a shoulder strap, and go anywhere he wishes. The larger one stays home, doing a good job of providing greater levels of oxygen to him, when he is there. John R. is so thankful for the gift he had received to help him on his journey, with IPF.

John R. had not ridden a bike for a very long time. But, in 2010, before he was diagnosed with Pulmonary Fibrosis, John R. and his wife, Hazel, decided to begin riding again! They started by riding the Confederation

Trail, tip-to-tip across the "Emerald Isle" as PEI is so often called. They had purchased hybrid trail bikes, equipped with saddlebags, bell, mirror and a comfortable seat. After this five day adventure, they continued to ride around Charlottetown, and in Victoria By The Sea, where they have a cottage.

But, John R. began to have difficulty pedalling, as his IPF became worse. He even had his Portable Oxygen Concentrator strapped to the rear parcel carrier! But over time, this became too heavy, and John was nervous that it may upset his balance and he would fall.

There were no magic wands waved and no "abracadabras" spoken. Yet, suddenly, a big magic gift appeared! John's son had found a battery-boosted tricycle for his Dad! His sons and grandsons took a long time to assemble all the parts, but it was a perfect fit for what John now needed. The rear cargo compartment held the Portable Concentrator, so he could just remove it and use it wherever he went. John's sense of humour shone through, when he said, "So now, I have come full circle: *trike - to bike - to trike!*"

John D. has his own biking experience that he loves to tell. He is a man who loves adventure. Once he even sailed solo, around the world - on a yacht! It was to make people more aware of "Diabetes." Can you guess what he decided to do? If you said, "bike ride," you would be absolutely correct. Prince Edward Island would be the perfect place to ride the seven-hundred kilometer Island Walk Route. Part of his ride would be on the Confederation Trail, while most of the time he would be on the roads around the coastal paths of the province.

John D. had an exciting event at the Joseph A. Ghiz Memorial Park, in Charlottetown. This was the launch of the national, Canadian Pulmonary Fibrosis Foundation campaign, called "Hope Breathes Here." John's venture was known as, "I Ride For You and Me - John Dennis." Guess who else was at John's wonderful kick off? Yes, John R. and some of his family!

It was an exciting day for both of these men, in different ways. John D. set out on his long ride, with the Mayor of Charlottetown, Philip Brown, pedalling beside him and wishing him well. But, little did John R. know that there would be a huge magical gift, for him that morning, as well. You see, John R. had thought for a long time that it was unfair that all Pulmonary Fibrosis patients were not treated the same. If you did not know what caused your disease, the Provincial Government would pay the cost of OFEV medication. But, If you knew how you became ill with the disease, you had to pay for the expensive drug yourself. Some people certainly could not afford it, so had to do without. John R. previously wrote a letter to Premier Dennis King, and his officials, and that very morning in the park, the Minister of Health, Hon. Ernie Hudson, announced funding for ALL patients struggling with this terrible disease. He also said he is hoping there will be new legislation, regarding organ donations, as early as in the fall of 2022.

So, both of these dear men had smiles on their faces. They had been given "Magic Gifts" - John D. got a big send-off for his ride, and John R. had gotten a gift that would help others. He had dreamed about this gift for a long time!

John D. mounted his bike, and off he began his ride of a lifetime! The wind blew so hard, at the beginning, that he had to have his friend, Marlene, pick him up and drive him to the motel. Over the next few days, John D. fell off his bike, not once, but twice. Each time he was injured and had to go to the Emergency Department at the local hospital. But, he had courage to keep trying, until he knew he could do no more! So many had helped him. He was well cared for by the nurses and doctors. As well, he had what he called his, "Trail Angels" who looked after all his needs as he rode along. He raised a large amount of money, and increased public awareness about IPF.

These two heroic gentlemen have not finished their adventures yet. John D. has a dream to pitch a ceremonial baseball, at a Blue Jays' game. He even wishes to be interviewed on the large Jumbotron screen, making more people aware of Pulmonary Fibrosis.

John R. and his wife, Hazel, have a wonderful honour to be bestowed on them, in the fall of 2022. They will be awarded "The Order Of Canada," by the Governor General of Canada. She will, hopefully, travel to Prince Edward Island, to present them with their medals, as John R. is not well enough to travel to Canada's capital, Ottawa.

The real story we learn from these two fine gentlemen is to never give up on your dreams, and "Magic Gifts" can be yours. So pedal hard on your journey through life, and you will successfully reach your destination.

## **Winnipeg Conference**



There were 10 responses in favour and 0 opposed.




